3. **Songs in the Professional Section to be submitted on CD**
4. **All Songs can be submitted on the one CD, no lyrics are required**
5. **Please write name of song/songs on CDS only,
Please supply **Four** Clearly Written copies of the Lyrics for each Song in Lyrics only Section.**
6. **Do not write your name on lyrics or cd.**
7. **Words and Music must be original and must not have been Commercially recorded and released prior to closing date.**
8. **An Amateur Writer is defined as one who has never won a major songwriting competition or who has not had 500 or more recordings of any one title for commercial use.**
9. **No restrictions on voice or backing in Professional section.**
10. **It is in the best interests of all contestants to make sure their recordings are as clear as possible.**
11. **An entry fee of \$10.00 per song Or lyrics only must accompany each entry;
cds and lyrics will be destroyed after judging unless a stamped self-addressed jiffy bag accompanies entry.**
12. **The judge's decision will be final and no correspondence will be entered into.**
13. **Top five (3) Finalists will be notified by phone on or after 21st April 2010**
